FSI in-factory repairs are warranted (under the same conditions) for 90 days against reoccurrence of the same problem. Except for this repair warranty, there is no warranty on services except that the billed-for hours were worked. On FSI Machine Vision solutions, we offer an optional separate Assured Path to Success™ program which is in addition to our warranty. Material may only be returned to FSI upon obtaining (and subject to) a return authorization from FSI. To cancel or indefinitely or substantially delay all or part of the undelivered balance, it is understood that the Buyer shall be obligated to pay for any partially completed units, special materials which have been purchased for the contract, FSI's direct and overhead expenses incurred, and for any price difference in quantity taken vs. quantity ordered. Buyer agrees to pay such charges within 30 days after such action. FSI shall be entitled, in addition to all other remedies available by law, to recover reasonable attorney fees and/or other expenses in collecting the purchase price or otherwise enforcing or successfully defending itself in respect of this sales contract. Products sold by FSI are not generally returnable due to transaction costs and due to most equipment being built to order, but there are exceptions to this statement.

All contracts involving the sale of merchandise by FSI shall not grant to the Buyer any license or right of any kind under any patent owned or controlled by FSI or under and patent under which FSI had a license, except as a patent license may be specifically granted in writing. All contracts involving the sale of merchandise by FSI must guarantee and protect FSI against infringement of any letters, patents, copyrights, trademarks, or trade names which may arise through application or use of the merchandise.

Terms (with approved credit) for orders under \$5000 are net 30 (payment due before 30 days after shipment date); freight, additional costs associated with export, special handling and special packaging are additional. For orders \$5000 - \$15,000 they are the same except payment schedule is 1/2 to fully proceed and 1/2 net 30. The same applies for orders in excess of \$15,000 except the payment schedule is 1/3 to fully proceed, 1/3 to ship, and 1/3 net 30. Overdue payments are subject to a 1 1/2% per month interest charge plus addition of costs expended for collection of payment. Our minimum billing per customer-defined release is \$100; otherwise it may be waived for a \$20 additional charge. Buyer must guarantee and protect FSI against infringement of any letters, patents, copyrights, trademarks, or trade names which arise from application-related issues of FSI products, or from customer specified Custom Built Merchandise, and indemnify FSI from any resultant claims, suits, or actions.
